### Directions for use

Situation	Use Rate	Critical comments
APPLES	5 - 7 L/Ha	7 - 14 days apart at petal fall until harvest.
STONE, POME TROPICAL FRUIT	2 - 4 L/Ha	To improve firmness & quality. Apply as required.
VINES	5 - 7 L/Ha	Apply at fruit set, followed by 3 applications 2 - 3 weeks apart.
LETTUCE	3.75 - 10 L/Ha	14 day intervals from emergence as required.
STRAWBERRIES	2 L/Ha	During flowering at 10 - 14 day intervals.
Dilute Caltop 1 : 100 for folia applications. Do not apply under extreme conditions such as high humidity, temperatures above 28°C, rain or frost.		
POST HARVEST DIP - Golden Delicious - Other varieties	600 mL/100 Ltr 1 - 2 Ltr/100 Ltr	As damage such as black spot can occur at high use rates, pH of tank solution should be checked and adjusted if necessary to neutral pH 7. Addition of QUATRABUFF™ at 3 - 5 mL/100 Litres will normally be sufficient.

CALTOP is 16.5% liquid Calcium for the correction of Calcium deficiencies in fruit and vegetables. Application of CALTOP can assist in the prevention of Tip Burn, Bitter Pit and Blossom End Rot. Quality, texture and storage condition can also be improved. CALTOP is compatible with most chemical sprays and is suitable for foliar application and post harvest dipping. When using for post harvest dipping, pH of tank solution should be checked and adjusted if necessary to neutral pH 7. Acetic acid (vinegar) or acidic products such as QUATRABUFF™ can be used.
