## **RATES OF APPLICATION**

Use Bind-R at a rate of 0.1% dilution of the final water volume in the spray tank (see example chart). If spraying conditions indicate impending rainfall or irrigation, the Bind-R should be used at a rate to give 0.14% dilution of the final water volume in the spray tank.
