DIRECTIONS FOR USE

SITUATION	APPLICATION RATE	CRITICAL COMMENTS.
Boom Sprayers Tournament Rate Fairways, playing fields	20 - 50L/Ha	Apply in at least 800 – 2000 Ltrs water per Ha. Water in well immediately after application. Apply monthly.
Standard Rate Parks, ovals	3 - 7L/Ha	Apply in at least 400 – 800 Ltrs water per Ha. Follow normal irrigation schedule. Apply monthly or as required.
Broadacre use Injection irrigation	1 - 3 L/Ha/Week	To improve efficiency of applied water. Higher rate gives best utilization of water. Apply as required throughout the growing season.

Broadwet does not usually require to be watered-in following direct injection application, however turf should be irrigated before next mowing. If applied in very dry conditions follow up with watering-in. For sensitive varieties high rate applications should be trialed first.

Broadwet is a blended nonionic soil penetrant that improves the penetration and infiltration of applied irrigation water. Broadwet provides an economical treatment to improve turf quality and gives best results with regular application. Broadwet may be applied through conventional spray equipment or by irrigation systems. Application is monthly or as required.

STORAGE AND DISPOSAL:

Keep out of reach of children.
Store in closed, original container in a well ventilated area, as cool as possible. Do not store for prolonged periods in direct sunlight.
