### Directions for use

Situation	Application Rate	Critical comments
PREMIUM PROGRAM Regular application to achieve most uniform standard.	20 L/Ha	Apply in at least 800 L/Ha of water carrier. Apply at 4 weekly intervals or as required.
LOW MAINTENANCE PROGRAM 90 days effectiveness with limited applications.	50 L/Ha	Apply in at least 2000 L/Ha of water carrier. Apply every 3 months.
WATER OPTIMISATION PROGRAM Restore liquid Terracare	10 L/Ha 20 L/Ha	Apply in at least 1000 L/Ha of water carrier. Apply together at 4 weekly intervals. Water run off and loss through evaporation is reduced.

**Apply in early cool hours of the day and water in well. Early application in mid spring with a follow up treatment in mid summer will usually provide good protection from dry patch and water repellency. Spot treatments with a hand gun can be used to treat problem spots if they occur.**

For general purpose use to maintain water infiltration. Excellent access to nutrients is achieved and turf health and vigour is maintained. Root moisture is maintained ensuring efficient water use.

#### GENERAL INSTRUCTIONS

RESTORE is a nonionic surfactant suitable for use in most situations where water repellency inhibits or prevents the growth of turf, gardens and crops. If left untreated poor water penetration leads to weak root growth, poor nutrient uptake and low crop yields or death of sensitive plants and turf. RESTORE provides uniform penetration of water to water repellent soils and continues to achieve deep penetration even as it dilutes while watering in. RESTORE is very long lasting and in some situations will continue to function for 12 months. Use with herbicides and fertilizers in turf is not recommended as it may increase the phytotoxicity of those chemicals. It is a wise precaution to test all mixtures before committing to large scale use.

#### MIXING

RESTORE mixes easily with water and should be added directly to the spray tank after the loading of water. Gentle mixing will minimise foam generation.
